#### RESPECT FOR MARRIAGE?

On December 9<sup>th</sup> of this year, H.R. 8404, the mis-named *Respect for Marriage Act*, was presented to the president. This bill, sponsored by Jerry Nadler, was introduced back in the summer on July 18.

This bill provides statutory authority for same-sex and interracial marriages. Specifically, the bill replaces provisions that define, for purposes of federal law, marriage as between a man and a woman and spouse as a person of the opposite sex with provisions that recognize any marriage between two individuals that is valid under state law (https://www.congress.gov/bill/117th-congress/house-bill/8404).

Any faithful and thinking Christian knows that so-called, "same-sex-marriage" is an abomination to God, and therefore, it should be to them also. That is not really my purpose here. What I would like to point out is some of the determined confusion surrounding this bill.

Notice *how* this bill is labeled: "Respect for Marriage". Such a misnomer is a common tactic of Satan and his allies as they ever disregard God and His word. Example: marriage—as defined by God—is the union of one man and one woman for life (Gen. 1:24-25; 1 Cor. 7:2). This bill actually *disrespects* marriage. We should not be surprised, however, God's law for marriage has been disrespected for millennia, and even by Christians in adulterous unions who love their spouses more than they love God.

Second, in the description of the bill they remind us that "The Supreme Court held that state laws barring same-sex marriages were unconstitutional in *Obergefell v. Hodges* in 2015" (ibid). Then, they have the daring to reference that "the Court held that state laws barring interracial marriages were unconstitutional in *Loving v. Virginia* in 1967" (ibid), as though the issues are remotely the same. In God's eyes, any two consenting adults who meet scriptural eligibility requirements may be married. Same-sex couples do not meet such requirements, and as long as they persist in the sinful practice of homosexuality, cannot meet them.

So far, "[t]he bill does not (1) affect religious liberties or conscience protections that are available under the Constitution or federal law, (2) require religious organizations to provide goods or services to formally recognize or celebrate a marriage", but as with other things, I'm sure its only a matter of time. Most folks my age and older, and many Christians can see the inherent dangers of promoting such unauthorized (sinful) behavior, but the ones mostly in jeopardy are the un-churched folks who will be born into a world where deviant, sexual behavior is considered normal and celebrated—%.
